# 2. ACCEPTANCE OF OFFICE BY A NEW MEMBER

Following an interview, recommendation by the Staffing Committee to the council of Mr Lee Osborne suitability in becoming a new member.

The Local Government Act 1972 s 83 (4) requires that a person elected to the office of parish councillor shall make in the presence of the council and deliver to the council a declaration of acceptance of office in a form prescribed by the Secretray of State.

Lee Osborne having been elected to the office of co-opted member of this parish council to declare that he would take that office upon himself and will duly and faithfully fulfil the duties of it according to the best of his judgement and ability.

As a newly co-opted member of New Frankley in Birmingham Parish Council, Cllr Osborne must give notice of his interests, both pecuniary and non-pecuniary, which must be declared under the council's Code of Conduct for members. Within 28 days of election, the co-opted member must register his interests in a public register by providing written notification to the City Council's Monitoring Officer.
